the Trust, from individuals, Body Corporate, lenders, Banks or Financial

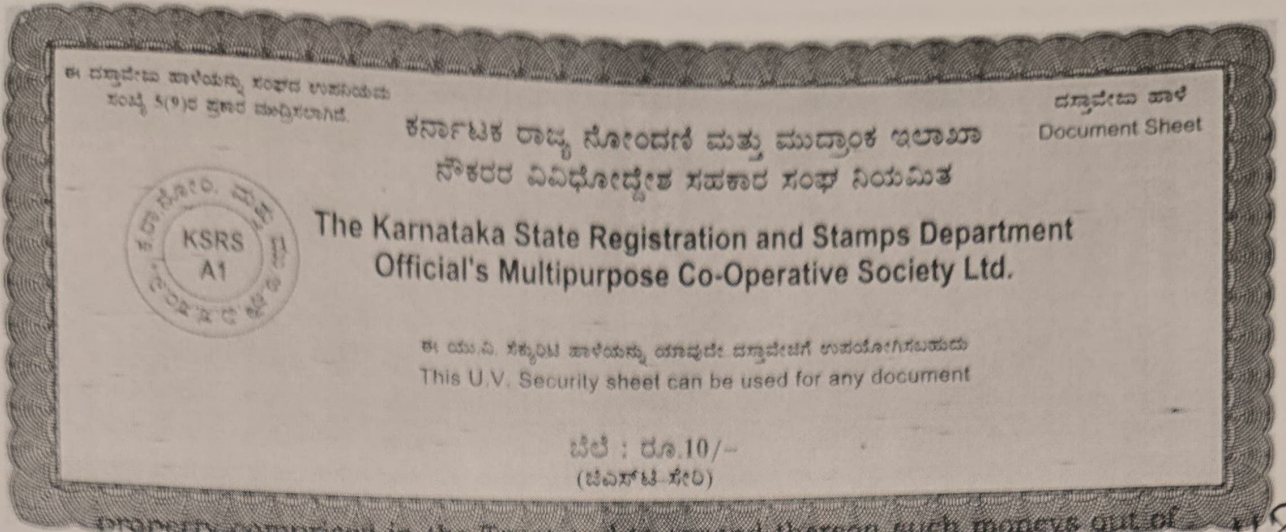

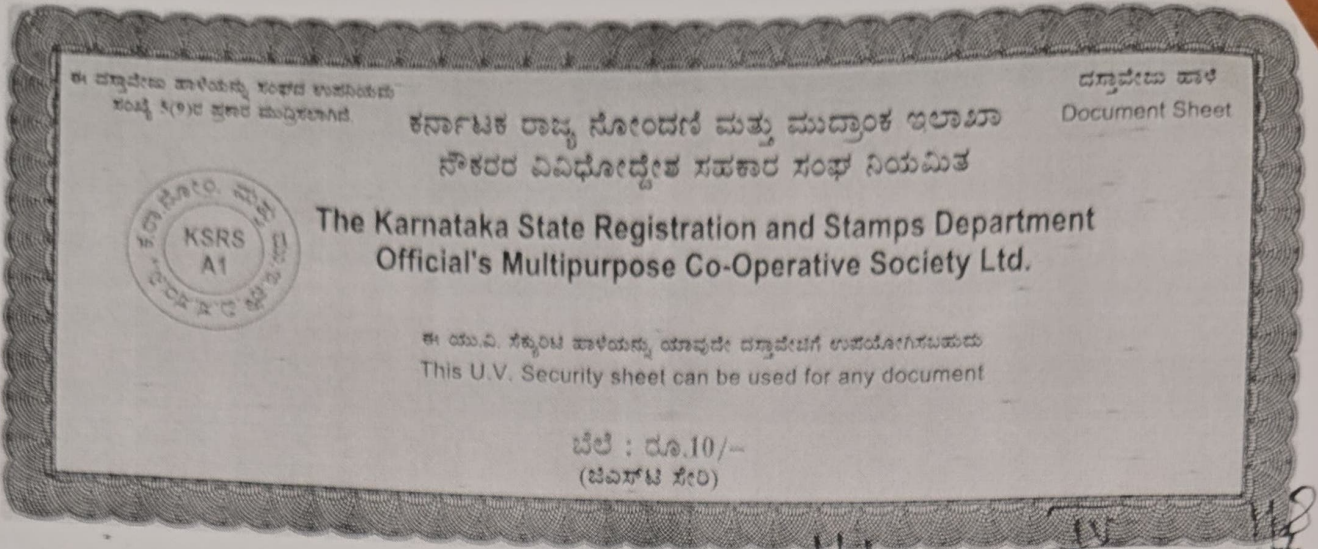
